Subject: First Amendment to the Agreement between Lassen County and Restpadd Health Corp. to provide Acute Psychiatric Inpatient Care under the Short-Doyle Act for the term of July 1, 2023, to June 30, 2025. The total Maximum Contract Amount is \$400,000 to include \$200,000 for FY 2023/2024 and \$200,000 FY 2024/2025.

Background:

Restpadd Health Corp is an inpatient acute care treatment facility licensed by the State of California Department of Health Care Services, designed as a 2-unit facility that treats both adults 18 and older, and adolescents ages 13 to 17. The design of the facility prevents mingling between adults and adolescents. Each unit is staffed daily with at least two nurses and two mental health technicians.

The Short-Doyle Act seeks to encourage the treatment of a patient suffering from a psychiatric disorder in his home community, with the assistance of local medical resources. Since Lassen County does not have any inpatient psychiatric facilities we are forced to contract with out-of-county facilities.

Fiscal Impact:

This will be paid from Behavioral Health Fund/Budget Unit No. 110/751 and Mental Health Services Act Fund/Budget Unit No. 164/0752.

Action Requested:

1) Approve the Agreement with Restpadd, Corp.; and 2) Authorize the County Administrative Officer to execute the agreement.

**FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Restpadd Inc., a California corporation (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2023 through June 30, 2025, (the "Agreement") in which CONTRACTOR agreed to provide acute psychiatric inpatient care.

2. **Amendments:** The parties agree to amend the Agreement as follows:

a. The parties desire to extend the Maximum Contract Amount to include FY 2024/2025. Therefore, Exhibit B is deleted and replaced with the following:




