Background:

On November 10, 2025, the agreement between Lassen County and Community Medical Specialist was approved. The agreement is for afterhours emergency response and evaluations. This amendment is to correct the term date from February 01, 2025, through June 30, 2026, to the correct term of July 01, 2025, through June 30, 2026. There are no changes to the scope of work, payment grid, or the maximum amount of \$300,000.

This Agreement will be paid from Behavioral Health Fund/Budgets 110/0771, 110/0751, and 164/0752.

FIRST AMENDMENT TO AGREEMENT BY AND BETWEEN LASSEN COUNTY AND COMMUNITY MEDICAL SERVICES

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Community Medical Specialists, Inc. (hereinafter "CONTRACTOR"), who agree as follows:

1. Recitals: This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of February 1, 2025, through June 30, 2026 (the "Agreement") in which CONTRACTOR agreed to provide after-hours emergency responses and evaluations in accordance with California's Welfare and Institutions Code (WIC) Article 1 (5150).

- 2. Amendments: The parties agree to amend the Agreement as follows:
 - a. The parties desire to correct the term for the FY 2025-2026. Therefore, the first sentence of Section 2 is deleted and replaced with the following:

"The term of this agreement shall be for the period of July 1, 2025, through June 30, 2026."

3. **Effectiveness of Agreement:** Except as set forth in this First Amendment, all provisions of the Agreement signed October 22, 2025, shall remain unchanged and in full force and effect.
