RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LASSEN, STATE OF CALIFORNIA, NAMING THE LASSEN COUNTY ARTS COUNCIL AS LASSEN COUNTY'S DESIGNATED LOCAL PARTNER WITH THE CALIFORNIA ARTS COUNCIL FOR THE FISCAL YEAR 2023/2024 STATE- LOCAL PARTNERSHIP PROGRAM AND RELATED AUTHORIZATIONS

WHEREAS, the California Arts Council's State-Local Partnership Program was established to foster cultural development on the local level through a partnership between the California Arts Council and the state's local arts agencies; and

WHEREAS, the State-Local Partnership program provides grant funding, general operating support and technical assistance for county-designated local arts agencies; and

WHEREAS, to submit a grant application and receive grant funding, applicant organizations must be designated by their County Board of Supervisors to serve as the State-Local Partner in the county; and

WHEREAS, the Lassen County Arts Council is requesting to be the County of Lassen's designated state-local partner, to be authorized to submit an application for grant funding from the State-Local Partnership Program, and if the grant is awarded, to execute the grant agreement; and

WHEREAS, by Resolution No. 22-005 the Lassen County Board of Supervisors had designated and approved of the Lassen County Arts Council to be the County's local partner for fiscal year 2022/2023.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lassen that:

- 1. The Lassen County Arts Council is the County of Lassen's designated local partner with the California Arts Council for the State-Local Partnership Program.
- 2. The Lassen County Arts Council is authorized to submit a grant application to the California Arts Council's State-Local Partnership Program.
- 3. Authority is delegated, if the grant is awarded to the Lassen County Arts Council to sign and execute the fiscal year 2023/2024 State-Local Partnership Program grant agreement with the State of California for the entire grant activity period of October 1, 2023 to September 30, 2024.
