**Subject:** First Amendment to the Agreement between Lassen County and Star View Behavioral Health Inc., aka Star View Adolescent Center, to provide needed mental health services for children and adolescents. Raising the Maximum Amount for the term of March 14, 2025, through June 30, 2025, to \$174,240 and raising the Maximum Amount for the term of July 01, 2025, through June 30, 2026, to \$522,720.

#### Background:

Star View Adolescent Center in Torrance serves the highest-needs adolescents in California. It is a comprehensive mental health treatment program for young people with severe emotional challenges who cannot be treated effectively in other existing community-based intensive treatment programs. Star View's multilevel program combines high-quality residential care and educational services with mental health treatment and rehabilitation. Unique in California, their integrated program eliminates the need to admit children in acute psychiatric crisis to a hospital where they are unknown and very well might not be able to resume their residential placement.

Star View Adolescent Center treats children who have experienced severe complex trauma or children with serious emotional challenges requiring intensive services in a secure environment. The center has 60 beds for those between the ages of 12 and 17 years.

#### Fiscal Impact:

There is no impact on the County General Fund. This Agreement will be paid from Behavioral Health Fund/Budget 110/0751 and Mental Health Services Act Fund/Budget Unit No. 164/0752.

#### Action Requested:

1) Approve the Amendment with Star View Behavioral Health Inc., aka Star View Adolescent Center, and 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

**FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Star View Behavioral Health Inc. aka Star View Adolescents Center (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of March 14, 2025 through June 30, 2026, (the "Agreement") in which CONTRACTOR agreed to provide need for mental health services for children and adolescents.

2. **Amendments:** The parties agree to amend the Agreement as follows:

a. The parties desire to extend the Maximum Contract Amount to include FY 2024/25 and FY 2025/26. Therefore, Exhibit B is deleted and replaced with the following:
