Subject: Second Amendment to the Agreement between North Valley Behavioral Health, LLC. and Lassen County Health and Social Services to raise the Maximum Contract Amount for both Fiscal Years 2023/2024 and 2024/2025 to \$450,000 to provide acute psychiatric inpatient care to the residents of Lassen County.

Background:

North Valley Behavioral Health, LLC is a client-first organization with three locations, that promotes self-awareness and acceptance in personal wellness and recovery. They work within the county health mental continuum of care to provide coordinated acute care, sub-acute care, and specialized programs in a safe and supportive environment for adults with severe and persistent mental health and co-occurring disorders. Their goal is to provide quality and compassionate care inpatient psychiatric services to adults within the Northern California region.

We are amending the FY 2023/2024 Agreement due to \$10,000 in overages on the maximum contract amount, therefore the Maximum Contract amount is to reflect \$450,000 to keep our client(s) in the facility and receiving the high-quality care they need and accommodate the added costs from FY 23/24.

Fiscal Impact:

This Agreement will be paid from Fund and Budgets 110/0771, 110/0751 and 164/0752, 165/0751 and is included in the FY 2024/2025 budget.

Action Requested:

1) Approve the Second Amendment to the Agreement with North Valley Behavioral Health, LLC.; and 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

**SECOND AMENDMENT TO AGREEMENT
BY AND BETWEEN
LASSEN COUNTY
AND
NORTH VALLEY BEHAVIORAL HEALTH, LLC**

THIS SECOND AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and North Valley Behavioral Health, LLC (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This Second Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2023 through June 30, 2025, (the "Agreement") in which CONTRACTOR agreed to provide acute psychiatric inpatient care to the residents of Lassen County.

2. **Amendments:** The parties agree to amend the Agreement as follows:

- a. The parties desire to extend the Maximum Contract Amount to include FY 2023/2024 and FY 2024/25. Therefore, Exhibit B is deleted and replaced with the following:
