INFORMATION SERVICES

AGREEMENT FOR LASSEN COUNTY OFFICE OF EDUCATION SUBJECT: Agreement to provide network and technology services and

support between the County of Lassen and the Lassen County Office of Education.

FISCAL IMPACT: Paid from the Internal Services Department Fund/Budget Unit No.104-0322, or other County Departments as needed and budgeted. The amount is not to exceed \$120,000, per year.

ACTION REQUESTED: 1) Approve agreement for network and technology services and support between the County of Lassen and the Lassen County Office of Education, for a three-year period Fiscal Year 2024/2025 through Fiscal Year Fiscal Year 2026/2027); and 2) authorize the County Administrative Officer to execute the agreement.

Information Services Department (ISD) Supervisor Jason Housel informed the board this item was a three year agreement with Lassen County Office of Education (LCOE) to provide network and technology services and support. ISD Supervisor Housel stated the county had a long standing relationship with LCOE and discussed the cost. Supervisor Neely asked about the services LCOE provided. ISD Supervisor Housel stated they assisted with projects, built workstations, camera and audio installation, as well as consulting. Deputy CAO Tony Shaw informed the board Robert Tally from LCOE really helped the county when the 911 emergency response system failed in and couldn't be restored. Mr. Tally and his staff of technicians were quick to respond and was able to restore the system. Deputy CAO Shaw added that he also used Mr. Tally for administrative projects pertaining to broad band and fire updates. Lassen County had been utilizing LCOE services for over 20 years. ISD Supervisor Housel stated LCOE was also assisting with the Historic Courthouse renovation that included installation of live streaming board meetings and audio. This year the county primarily worked with LCOE for a lot of security upgrades and initiatives. Brief discussion was held.

HEALTH AND SOCIAL SERVICES

LASSEN COUNTY BEHAVIORAL HEALTH DRIVING UNDER THE INFLUENCE PROGRAM

SUBJECT: Discontinuing Driving Under the Influence Program at Lassen County Behavioral Health.

FISCAL IMPACT: If program is not discontinued additional licensing and contract fees will be incurred against Mental Health Fund/Budget Unit No. 110-0751.

ACTION REQUESTED: Approve the discontinuation of the DUI Program.

Health and Social Services Behavioral Health Program Manager Nichole Bond informed the board this item was a request to discontinue the Driving Under the Influence (DUI) Program. Program Manager Bond gave a brief background of the DUI Program and stated Behavioral Health didn't have the funding to continue the course and discussed the current pricing for a contracted instructor. Program Manager Bond said Behavioral Health had made an agreement with Butte County to enroll the current participants in their program. Supervisor Neely asked when a DUI offender was ordered to pay fines would the funding go to the county to pay for the DUI Program. Program Manager Bond said funding for the program came from the participants paying their bill. Participants who were in a financial burden would pay a reduced fee. DUI fines were paid to the state. Supervisor Albaugh stated he appreciated everything Behavioral Health had done.

PUBLIC WORKS DEPARTMENT

ENGINEERING DESIGN SERVICES FOR PUBLIC WORKS SUBJECT: Bid Award: Engineering Services for Whitehead Slough Bridge (7C-70)

FISCAL IMPACT: The not-to-exceed agreement amount is \$246,129.22. Funding will be budgeted in Fiscal Year 2024/2025 Road Construction Fund/Budget Unit No. 122-1222 and will be reimbursed through the Caltrans Highway Bridge Program. The design and associated expenditure will occur over the next several fiscal years.

ACTION REQUESTED: 1) Approve consultant agreement with Morrison Structures, Inc., to perform engineering services for the Whitehead Slough Bridge (7C-70); and 2) authorize the Public Works Director to sign an agreement with Morrison Structures for an amount not-to-exceed \$246,129.22.

SB1 ROAD FUNDING

SUBJECT: SB-1 Road Maintenance and Rehabilitation Account (RMRA) Funding Fiscal Year 2024/2025.

FISCAL IMPACT: Anticipated revenue in the estimated amount \$3,573,549 from the 2024/2025 appropriation of SB 1 RMRA Funds to the Fiscal Year 2024/2025 Road Fund No. 122.

ACTION REQUESTED: 1) Approve the resolution adopting a list of projects for Fiscal Year 2024/2025 funded by SB1: The Road Repair and Accountability Act of 2017; and 2) authorize the Chairman to sign.

Director Heimbigner stated Public Works tried to do one large project each year and briefly discussed prior projects. The next project would be a chip seal scheduled for Grasshopper Lane in Termo. Supervisor Neely asked about purchasing equipment. Director Heimbigner stated a new paint truck and a patching machine were purchased. The equipment was more efficient and required less maintenance. Director Heimbigner also stated staff time was charged to the SB1 funding for any maintenance projects. Brief discussion was held regarding dirt roads.
