Subject: First Amendment to the Agreement between Lassen County and Restpadd, Inc. to extend the Maximum Amount of the FY 2025/2026 to \$175,000 and FY 2026/2027 to \$200,000, making the Maximum Contract Amount not to exceed \$375,000.

Background:

Lassen County Health and Social Services respectfully requests approval of the First Amendment to the existing agreement between Lassen County and Restpadd, Inc. for the provision of acute psychiatric inpatient treatment services.

Restpadd, Inc. operates a 16-bed acute-care psychiatric inpatient treatment facility serving adults aged 18 and older. The facility provides multidisciplinary evaluation and treatment, rapid stabilization, and coordinated discharge planning that promotes ongoing wellness and recovery.

The purpose of this amendment is to increase the maximum contract amounts for the following fiscal years to ensure the continued availability of these critical services:

- Fiscal Year 2025-2026: Increase to \$175,000
- Fiscal Year 2026-2027: Increase to \$200,000.

This results in a revised total maximum contract amount not to exceed \$375,000.

Fiscal Impact:

This Agreement will be paid from Behavioral Health Fund/Budget No.110/0751 and Mental Health Services Act Funds No. 164/0752.

Action Requested:

- 1) Approve the First Amendment to the Agreement with Restpadd, Inc., and
- 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

**FIRST AMENDMENT TO AGREEMENT
BY AND BETWEEN
LASSEN COUNTY
AND
RESTPADD, INC**

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Restpadd, Inc., with a principal place of business at 2750 Eureka Way, Redding, CA 96001 (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2025, through June 30, 2027, (the "Agreement") in which CONTRACTOR agreed to provide acute psychiatric inpatient care to the residents of Lassen County under the Short-Doyle Act (Welfare and Institutions Code, Sections 5600, et seq.),

2. **Amendments:** The parties agree to amend the Agreement as follows:

a. The parties desire to extend the Maximum Contract Amount for the FY 2025/26 and FY 2026/2027. Therefore, the Attachment B Payment Grid is deleted and replaced with the following:


