NORCAL EMERGENCY MEDICAL SERVICES (EMS) JOINT POWERS AUTHORITY (JPA)

SUBJECT: Amendment to the Joint Powers Authority Agreement with NorCal EMS; Resolution Authorizing Background Checks for Emergency Medical Technicians.

FISCAL IMPACT: None.

County Counsel Plett informed the board this item was a Joint Powers Authority (JPA) with Norcal Emergency Medical Services (EMS) and gave a brief overview of the organization. County Counsel Plett stated this item was an amendment to the previous agreement reinstating Norcal EMS back into a non-profit organization status. After entering into a JPA, the state and federal government required background investigations on all Emergency Medical Technicians. The background investigation was being delayed by the state and federal government therefore forcing Norcal EMS to return to the non-profit status to continue medical services and remain in compliance while waiting for approval. The amendment reinstates the non-profit organization status.

CHANGE IN PUBLIC HEALTH ALLOCATED POSITIONS FOR FISCAL YEAR 2025/2026

SUBJECT: Lassen County Public Health Department is requesting to un-fund a vacant Program Manager position and fund an Administrative Manager position within Fund/Budget Unit No. 110-0731.

FISCAL IMPACT: This will be a cost savings to the Public Health Fund/Budget Unit No. 110-0731.

ACTION REQUESTED: 1) Un-Fund 1 Vacant Full Time Employee (FTE) Program Manager position with Public Health; and 2) fund an additional 1 FTE Administrative Manager position with Public Health.

Health and Social Services Assistant Director/Personnel Coordinator Danielle Sanchez stated this item was for a change in an allocation of positions for the Public Health Department to unfund a Program Manager and add an additional Administrative Manager within that budget. This would be a cost savings of approximately \$17,000. Personnel Coordinator Sanchez gave a brief overview of the purpose of the change. Public Health Director Natalie Ruegger discussed the job function of an Administrative Manager. Brief discussion was held.
