RE: Tobacco Grant Award and Resolution

Subject: The Lassen County Sheriff's Office is requesting the Lassen County Board of Supervisors approve a resolution to accept the funding from the California Department of Justice (DOJ) for Tobacco Enforcement and Prevention.

Discussion: In the fall of 2025, the Sheriff's Office applied to renew funding from DOJ to continue the Tobacco Enforcement and Prevention Program. On December 4, 2025, we received an award in the amount of \$725,492 for the 2026/27 fiscal year. The grant award cycle will end in fiscal year 2028/29. This award will fund enforcement operations including prevention, education and enforcement of tobacco laws and regulations throughout the County of Lassen. This will include checking for proper posting of laws, undercover operations, shoulder taps operations and decoy buy operations.

The Sheriff's Office is requesting a resolution from the Board of Supervisors to accept the funding and execute the Memorandum of Understanding with DOJ. The funding will be allocated to and expended from Budget Unit 129-0538.

Fiscal Impact: Revenue to Budget Unit 129-0538 in the amount of \$725,492.00. The funding will be expended from the same budget unit. No projected fiscal impact to the General Fund for fiscal year 2026/27 is anticipated.

Recommendation: 1) Approve the proposed resolution accepting the award from the California Department of Justice; 2) Authorize the Chairman of the Board to execute the MOU with DOJ; 3) Allocate the awarded revenue to Budget Fund 129-0538, 4) Authorize the funding to be expended from Budget Unit 129-0538 and/or; 5) Provide direction to staff.



MEMORANDUM OF UNDERSTANDING

PURPOSE

This Memorandum of Understanding ("MOU") is entered into by the Department of Justice ("DOJ") and the Lassen County Sheriff's Office ("Grantee"), for the purpose of disbursing grant funds to Grantee for reimbursement of expenditures in compliance with the California Code of Regulations and the Fiscal Year 2025-26 Grantee Handbook.

Commencing January 1, 2023, the California Code of Regulations, Title 11, Division 1, Chapter 5: Department of Justice Tobacco Grant Program ("TGP Regulations") shall govern the policies and procedures of the Tobacco Grant Program.

The TGP Regulations, Request for Proposals, Grantee Handbook (dated April 2025), and Summary of Award document are hereby incorporated by reference into this MOU. Grantee will expend funds for the purposes identified in the approved Summary of Award document. Reimbursements are to be funded under the California Healthcare, Research and Prevention Tobacco Tax Act of 2016, approved by the voters as Proposition 56.

COST REIMBURSEMENT

DOJ agrees to reimburse Grantee in arrears, for Grantee's actual expenditures in performing the project or scope of work included in the approved Summary of Award document. Reimbursements for line items in the approved Budget Detail will be made upon receipt of invoices from Grantee and approval of the invoices by DOJ, in accordance with the reimbursement procedures set forth in the TGP Regulations and Grantee Handbook.

BUDGET CONTINGENCY CLAUSE

It is mutually agreed, if the Budget Act of the current fiscal year and/or any subsequent years covered under the MOU does not appropriate sufficient funds, the MOU shall be of no further force and effect. In the event this situation occurs, DOJ shall have no liability to reimburse/pay any funds to Grantee, or to furnish any other considerations under this MOU. As well, Grantee shall not be obligated to continue performing the provisions of this MOU, for which the Grantee would have been reimbursed.

If funding for any fiscal year is reduced or deleted in the Budget Act for purposes of this MOU, DOJ shall have the option to either cancel this MOU with no liability occurring to DOJ or offer an addendum to the Grantee to reflect the reduced amount.

PROJECT BREACH-TERMINATION

Failure of a Grantee to comply with this MOU or the TGP Regulations shall be treated by DOJ as a breach of contract. If an act of noncompliance occurs, DOJ may take actions described within the TGP Regulations, including termination. DOJ may terminate this MOU and be relieved of any obligation to disburse grant funds to Grantee should Grantee fail to perform the scope of work at the time and in the manner provided in this MOU.

MISCELLANEOUS PROVISIONS

<u>Addendum</u> – No addendum or variation of the terms of this MOU is valid unless made in writing and signed by the duly authorized representatives of the parties.

Assignment - This MOU is not assignable by Grantee in whole or in part.

<u>Indemnification</u> – Grantee agrees to indemnify and hold harmless DOJ, its officers, agents and employees from all claims, liabilities, or losses in connection with the performance of this MOU.

<u>Certifications</u> – Grantee certifies that it does not receive funding from a manufacturer, distributor, or advertiser of Cigarettes or Tobacco Products. Grantee further certifies that grant funds will not supplant existing state or local funds dedicated for the same purpose.

Recruitment will be done by word of mouth using local youth that we know in our community. Decoy operations will have a Sheriff Deputy on scene to ensure the safety of our decoy, staff, and community members in the area of the operations. We will follow up with our local district attorney and court to ensure violators who have been issued citations are showing up for court and being prosecuted for their violations of the tobacco laws.

Undercover Buys

- Per year, 6 undercover buy operations will be conducted (other than minor decoy or shoulder tap).
- Per year, **34** retailers will be targeted through these operations.
- Additional details regarding these undercover operations:
 - Undercover operations will be conducted at a lower frequency than our shoulder tap operations as we will be using our jail staff who are under the age of 21 to conduct these operations and will need to work around the jail staffing schedule to conduct these operations.
 - We will determine the retailers to target based on data collected and from staff conducting checks on our retailers. Undercover operations will have a Sheriff Deputy on scene to ensure the safety of our undercover deputy who will be in pain clothes without their duty weapons, staff, and community members in the operations. We will follow up with our local district attorney and court to ensure violators are being prosecuted for their violations of the tobacco laws.

Retailer Education

- Per year, 34 retailers will receive educational materials.
- Per year, 34 retailers will receive on-site education.
- Additional details regarding these retailer education activities:
 - O During weekly checks of our tobacco retailers throughout the county we will educate them on site for any tobacco law violations witnessed and discuss and educate them on any new changes to tobacco laws as they come into effect. Staff will ensure during the weekly checks that retailers have the most current and correct tobacco signage showing and posted where their customers can easily see it. Staff will also ensure on retail checks
