SUBJECT: Notice of Completion for Punkin Center Road CR 417 Rehab B Hot Mix Asphalt Overlay Project, Lassen County, Federal Aid Project RPSTPL-5907(054).

RECOMMENDATION: That the Board approve the Notice of Completion and authorize the Director of Public Works to sign.

DISCUSSION: Lassen County entered into a contract with Hat Creek Construction and Materials, Inc. on March 4, 2022 for the rehabilitation of a portion of Punkin Center Road, County Road 417 in the amount of \$1,989,989.00

The Contractor began work on September 14, 2022 and the project was substantially completed on October 7, 2022 and accepted by the Director of Public Works on February 27, 2023. Final acceptance by the County will be on May 23, 2023.

The final contract amount is \$2,142,568.99 which is under the total Board of Supervisors authorized amount, including contract change orders of \$ 2,288,487.00. The project was completed without any major issues and within the allowable working days. No liquidated damages were incurred on this project.

The attached Notice of Completion will formally close out the contract for this project.

FINANCIAL IMPACT: The total project cost of \$2,142,568.99 was paid from the FY 2022/23 Road Construction Budget, Fund 122-1222 with reimbursement from Federal STIP funding in the amount of \$1,995,000.00.

The work to be done consisted, in general, of the pulverization of the existing asphalt concrete surfacing and installation of a 3 inch asphalt concrete overlay on portion of Punkin Center Road, County Road 417, including shoulders and traffic striping and other related work, per the special provisions entitled "County of Lassen, State of California, Notice to Contractors, Proposal and Contract, Special Provisions for Punkin Center Road, CR 417 Rehab B Hot Mix Asphalt Overlay Project, Lassen County" also to be supplemented by the 2018 Standard Plans and Specifications, bid opening date November 4, 2021. Total final contract amount of \$2,142,568.99.

In the County of Lassen, all in the State of California was completed by said contractor and accepted by Pete Heimbigner, Director for Lassen County, on February 27, 2023.

Upon said contract, the Fidelity and Deposit Company of Maryland was the surety upon the bond by said contractor, as required by the provisions of Section 3247 to 3252, inclusive, of the Civil Code of the State of California and the State Contract Act.
