Subject: First Amendment to the Agreement between Community

Medical Specialists Inc. and Lassen County Health and Social Services to update the payment grid by adding lodging and mileage reimbursement and adding the Maximum Amount of \$400,000 for the 2023-2024 and \$400,000 for the 2024-2025 Fiscal Year and the Maximum

Agreement Amount of \$800,000.

Background:

On February 14, 2023, the Board of Supervisors approved the Agreement between Community Medical Specialists Inc. and Lassen for professional psychiatric, diagnostic, and therapeutic services. This First Amendment to the Agreement is to add lodging and mileage reimbursement as well as the Maximum Amount to the payment grid.

Fiscal Impact:

This Agreement will be paid from Behavioral Health fund/budget 110/0771, 110/0751 and 164/0752.

FIRST AMENDMENT TO AGREEMENT BY AND BETWEEN LASSEN COUNTY AND COMMUNITY MEDICAL SPECIALISTS INC.

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and COMMUNITY MEDICAL SPECIALISTS INC. (hereinafter "CONTRACTOR"). who agree as follows.

1. Recitals: This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of February 1, 2023, through June 30, 2025, (the "Agreement") in which CONTRACTOR agreed to provide professional psychiatric, diagnostic, and therapeutic services to Lassen County clients:
