SUBJECT: Introduce and Waive the First Reading of an Ordinance Amending Article I of Title 12 of the Lassen County Code (known as the Lassen County Building Code). The amendment will remove the requirement to install fire sprinklers within all residential structures over two thousand square feet, constructed under Chapter 12.27 of Lassen County Code.

Planning and Building Services Planning Manager Matt May informed the board this item was to introduce and waive the first reading of an amendment to the Lassen County Code. The amendment removed a requirement to install fire sprinklers in all residential structures that were over 2,000 square feet. The ordinance was exempt from the California Environmental Quality Act (CEQA) and would be brought back for adoption on April 15, 2025. This ordinance would also eliminate a density ordinance that was adopted by the board in February 2022. Planning Manager May stated single family residences under 2,000 square feet did not have the fire sprinkler requirement and explained limited density. Brief discussion was held.

SECOND AMENDMENT TO THE AGREEMENT BETWEEN KINGS VIEW PROFESSIONAL SERVICES AND LASSEN COUNTY SUBJECT: Second Amendment to the Agreement between Lassen County and Kings View Professional Services to provide Electronic Health Record System (EHRS) support services increasing the contract by \$35,435.38 for a total contract amount for Fiscal Year (FY) 2024/205 to \$381.265.76 a maximum contract amount of \$989,738.59 for FY 2022 through 2025.

Interim Director of Public Health Danielle Sanchez stated this item was an agreement between Locumtenens.com, LLC. and Lassen County for professional psychiatric, diagnostic, and therapeutic services for the term of February 1, 2025, through June 30, 2026. Interim Director Sanchez informed the board the county had not had an onsite psychiatrist in at least ten years and would be willing to hire an onsite psychiatrist if someone applied. County Counsel Uhrhammer said this was a very common problem in rural counties. Brief discussion was held.
