Third Amendment to the Agreement between Lassen County and Restpadd, Inc. for Acute Psychiatric Inpatient Care under the Short-Doyle Act to pay April, May and June invoices. For the term of July 1, 2023, to June 30, 2025. Increasing FY 2024/2025 by \$30,000 for a total not to exceed amount of \$160,000 and increasing the Maximum Contract Amount to \$290,000.

Background:

Restpadd, Inc. is a 16-bed acute care psychiatric inpatient treatment facility licensed by the California Department of Health Care Services, offering services to adults 18 years and older. Admission is based on the medical necessity of patients who are unable to maintain and safely function at home or in the community. Restpadd, Inc. provides multi-disciplinary evaluation, treatment, rapid stabilization, and coordinated discharge planning that encourages wellness and recovery.

Fiscal Impact:

There is no impact on the County General Fund. This Agreement will be paid from Behavioral Health Fund/Budgets 110/0751.

Action Requested:

1) Approve the Amendment to the Agreement with Restpadd Inc., and 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

THIRD AMENDMENT TO AGREEMENT BY AND BETWEEN LASSEN COUNTY AND RESTPADD INC.

THIS THIRD AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Restpadd Inc., a California corporation (hereinafter "CONTRACTOR"), who agree as follows:

1. Recitals: This Third Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2023, through June 30, 2025 (the "Agreement") in which CONTRACTOR agreed to provide acute psychiatric inpatient care.

- 2. Amendments: The parties agree to amend the Agreement as follows:
 - a. The parties desire to extend the Maximum Contract Amount for the FY 2024/2025 by \$30,000 to pay April, May, and June invoices. Raising the FY 2024/2025 Maximum Contract Amount from \$130,000 to \$160,000. Therefore, Exhibit B is deleted and replaced with the following:
