SUBJECT: Resolution Authorizing Submittal of Application, Acceptance of Funding Upon Allocation of Funds, and Execution of a Grant Agreement with the California Department of Transportation for an Acquisition & Development Grant for Spaulding Airport

**RECOMMENDATION:**

That the Board adopt a resolution authorizing the submittal of an application, acceptance of an allocation of funds upon allocation by California Transportation Commission and execution of a grant agreement with the California Department of Transportation, for an Acquisition & Development grant and certifying the availability of the County's share of matching funds.

**DISCUSSION:**

The California Department of Transportation, Division of Aeronautics has informed this department that an improvement project for the Spaulding Airport may be funded by the California Transportation Commission, in the Aeronautics Funding Program, if sufficient funds are available.

The project, generally, is pavement maintenance consisting of crack sealing and restriping the runway and taxiway with a total programmed cost of \$84,000.

**ALTERNATIVE:**

Not adopt resolution.

**FINANCIAL IMPACT:**

The grant requires a project match of \$8,000 (10%). Funds for the match are available in fund 124 Aviation.

A resolution of the Lassen County Board of Supervisors authorizing the submittal of an application, acceptance of an allocation of funds and execution of a grant agreement with the California Department of Transportation, for an Acquisition & Development grant and certifying the availability of the County's share of matching funds.

WHEREAS, the California Transportation Commission has adopted the 2016 Aeronautics Program for airport improvement projects; and

WHEREAS, the California Department of Transportation, pursuant to the Public Utilities Code and California Aid to Airports Program (CAAP) regulations, requires local government approval authorizing the application and certifying the availability of 10% matching funds, a sum from other than state or federal sources; and

WHEREAS, the County of Lassen is submitting an application for pavement maintenance and remarking of runway, taxiway and tiedown area at Spaulding Airport, which is included in the 2016 Aeronautics Program;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of Lassen, State of California:

1. Authorizes filing the application for the project in the 2016 Aeronautics Program.
2. Authorizes accepting the allocation of funds for the project at Spaulding Airport.
3. Certifies the availability of the County's ten percent (10%) matching funds.
4. Authorizes execution of the Grant Agreement; and

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Lassen does hereby authorize Director of Public Works/Transportation to sign any documents required to apply for and accept these subject funds on behalf of the County of Lassen.
