

Lassen County Request for Proposals

Highlights

Nor-Cal EMS established an Ambulance Exclusive Operating Area (EOA) to ensure reliable, efficient, and equitable emergency services.

Based on an in depth Lassen County EMS system assessment and stakeholder input, a Request for Proposals (RFP) document has been developed to solicit proposals from qualified ambulance providers.

Process:

- Following this Board presentation, the RFP will go to the State EMS Authority for review and approval.
- Nor-Cal EMS will:
 - publish the RFP and will provide the procurement process to include selection of the highest scoring proposer, and.
 - negotiate a high performance contract for a period of five years with a five year extension based on Contractor's performance.
- The current contract with SEMSA expires July 1, 2025, and may need to be extended to allow time for a new provider to prepare for startup of operations.

RFP Highlights:

- Established minimum qualifications, scope of work, and insurance requirements.
 - Five years continuously engaged in 911 ALS transport.
 - Financial strength through demonstrating audited financial statements for the past five years.
 - Agree to a performance bond or an irrevocable Letter of Credit in the amount of \$500,000.
 - Agree to minimum insurance requirements.
- Ambulance response zones were updated to reflect the current population in Lassen County using GIS modeling by Nor-Cal EMS and reviewed by the EMCC Ad-Hoc Committee and approved by the Nor-Cal EMS Medical Director
 - Established 5 ambulance response zones:

- Zone 1 = 10:00 (Susanville and surrounding area)
- Zone 2 = 16:00 (Westwood and State Route 36, Janesville and area to the south of Susanville and East of 395)
- Zone 3 = 30:00 (Standish area and Prison)
- Zone 4 = 45:00 (395 south of Janesville into Herlong and Doyle)
- Zone 5 = 60:00 (all other areas with exemptions for off-road wilderness areas)
- Response time requirements with liquidated damages for underperformance
- Evidence based clinical performance standards with liquidated damages for underperformance
- Contractor will be required to enter into an agreement with Firenet Lassen for access to radio frequencies and SIFC dispatch services.
- Proposers will be evaluated on:
 - History of providing quality ambulance services
 - Proposed ambulance rates,
 - Evidence of financial stability
 - Proposed wages and benefits to attract and retain experienced personnel.
