PUBLIC NOTICE INSTRUCTIONS FOR TEMPORARY PERMIT APPLICATION T033518 OF LASSEN AND MODOC GSAs TO APPROPRIATE WATER FROM ASH CREEK IN LASSEN AND MODOC COUNTIES

The purpose of this letter is to inform you of your responsibility to provide notice to the list of interested persons maintained by your groundwater sustainability agencies or local agencies for the basin where the water is proposed to be stored. After delivering the public notice, the applicant shall provide proof of notice to the State Water Resources Control Board (State Water Board).

The State Water Board has developed the enclosed notice of your application, which you may use for your own noticing purposes. Your application must be noticed in accordance with Water Code section 1433.3, subdivision (b). The State Water Board will provide the enclosed notice to each person on the list of interested persons maintained by the State Water Board.

Objections

Any interested person may file an objection in response to the notice against the approval of your application within 30 days of delivery of the notice by the applicant. All interested persons filing an objection against your application should provide you, as well as the State Water Board, a copy of the objection. The State Water Board will give

prompt consideration to any objection.

Water right notices are designed for the mutual protection of the applicant and other parties claiming prior rights. Although vested rights to the use of water from the source from which an appropriation is sought cannot be lost, prejudiced, or impaired by failure to object to an application, known claimants to prior rights have been given this notice so that they may object if they believe the proposed appropriation will result in injury to them.

Notice of Temporary Permit Application T033518

Modoc and Lassen County GSAs filed a temporary permit application with the State Water Resources Control Board (State Water Board), Division of Water Rights, pursuant to Water Code section 1433.3 et seq. The project associated with the application is located in Lassen and Modoc Counties and would divert water from Big Valley Canal, Ash Creek, and Pit River, all tributaries to the Sacramento River. The Applicant requests authorization to appropriate surface water for underground storage as described below.

Summary of Temporary Permit Application T033518

Type of Temporary Permit: 5-Year Temporary Permit

Date of Filing: The application was filed with the State Water Board on September 3, 2025.

Sources of Water: Water would be diverted from the Big Valley Canal and Ash Creek, tributaries to Pitt River, and directly from Pitt River, which is tributary to the Sacramento River.

Amount: The maximum combined amount of water requested for diversion is 650 acre-feet (af) per year, which would be diverted at a combined maximum flow rate not to exceed 10 cubic feet per second (cfs).

Seasons of Diversion: The season for diversion would be from December 1 to March 14 for a five-year period, beginning December 1, 2025 through March 14, 2030.

Points of Diversion (POD): The application proposes using up to three points of diversion as described below.

Quail Ranch (rate of up to 4 cfs and volume up to 650 af)

(POD 1) By California Coordinate System of 1983, Zone 1, North 2,319,010 feet and East 6,805,398 feet, Section 25, Township 39 North, Range 7 East, Mount Diablo Base and Meridian.

Ash Creek Wildlife Canal (rate of up to 3 cfs and volume up to 650 af)

(POD 2) By California Coordinate System of 1983, Zone 1, North 2,302,996 feet and East 6,814,563 feet, Section 8, Township 38 North, Range 8 East, Mount Diablo

Base and Meridian.

Ash Creek Upland (rate of up to 3 cfs and volume up to 650 af)

(POD 3) By California Coordinate System of 1983, Zone 1, North 2,316,676 feet and East 6,828,193 feet, Section 27, Township 39 North, Range 8 East, Mount Diablo Base and Meridian.

Purposes of Use: Uses would include irrigation, municipal and domestic.

Place of Use: The water would be used within 92,000 acres of the Big Valley groundwater subbasin.

Location and Type of Infiltration: Water would be delivered to on-farm recharge areas for infiltration to underground storage.

- Diverted water from POD #1 will be infiltrated over a field of about 160 acres.
- Diverted water from POD #2 will be infiltrated over a field of about 130 acres.
- Diverted water from POD #3 will be infiltrated over a field of about 130 acres.

Use Accounting: The water stored underground would serve the domestic needs of approximately 730 people, the municipal needs of the Lassen County Waterworks District 1, and irrigation needs within the Big Valley groundwater subbasin.

Procedure for Filing Objections

Pursuant to Water Code section 1433.3, any interested person may file an objection against the approval of the subject application. Objections should be submitted via email to the staff and applicant contact listed below but may also be submitted via regular mail or hand delivered. If objections are sent by mail or hand delivered, please provide a courtesy email to the contact listed below.

Objections must be received by the Division of Water Rights or postmarked by October 10, 2025, with copy provided to the applicant. The State Water Board may, for good cause shown, allow additional time to file an objection.
