The project site is the VFW (Veterans of Foreign Wars) property in Herlong. A.P.N. 139-160-76 (portion); and

WHEREAS, the Environmental Review Officer of the County of Lassen has determined that review for conformity with a general plan, pursuant to Section 65402 of the Government code, is not a "project" as the term is defined at Section 15378 of the California Environmental Quality Act Guidelines.

Resolution Approving the Transfer of the Veterans Building and Adjacent Tennis Court Property Located at the Herlong Army Base to the Honey Lake Veterans of Foreign Wars, Post 6356

WHEREAS, the Lassen County Local Reuse Authority is a Public Corporation of the State of California, formed pursuant to the provisions of the Military Base Reuse Authority Act, California Government Code Sections 67800 et. seq.; and

WHEREAS, pursuant to the terms and conditions set out in the Memorandum of Agreement between the United States of America, acting by and through the Secretary of the Army, and the Lassen County Local Reuse Authority (LRA), dated October 22, 2003, the United States of America has transferred title to certain real property located at the Sierra Army Depot, in Herlong, California, to the LRA; and

WHEREAS, title to the property commonly referred to as the Veterans Building, and located at 1223 Sierra Street, Herlong, CA 96113, was transferred to the LRA as evidenced by the deed from the United States of America to the LRA dated October 22, 2003 and recorded in the official records of the Lassen County Recorder's Offices at 2003-10759 p. 1/58, and

WHEREAS, in order to facilitate the continued public use and enjoyment of the Veterans Building and adjacent tennis courts by veterans and other members of the local community, the Board of Directors agrees to transfer title to the Veterans Building and the adjacent tennis court property to Honey Lake Veterans of Foreign Wars, Post 6356, as a non-profit organization (referred to herein as the "VFW"), in trust and conditioned on the VFW maintaining and using said building and property as a facility for the benefit of veterans and for such other public use thereof as a meeting facility, community hall and recreational facilities to serve the community of Herlong and south Lassen County; and

WHEREAS, the Board expressly finds that the transfer of the aforesaid properties to the Honey Lake Veterans of Foreign Wars, Post 6356, complies with the goals and objectives as set out in Section 1.1 of the Sierra Army Depot Reuse Plan pertaining to properties transferred to the LRA, in that use of the properties as described herein will contribute to maintaining the integrity and viability of the Herlong community and will preserve the social values of the community by affording them a social gathering place and recreational opportunities.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE LASSEN COUNTY LOCAL REUSE AUTHORITY THAT the Board hereby authorizes the transfer, in trust, of the real property described below to Honey Lake Veterans of Foreign Wars, Post 6356, as a non-profit organization, for the use and benefit of the of veterans and the community of Herlong as a meeting facility, community hall and recreational facilities to serve the veterans and members of the public.

This transfer is further conditioned on the Honey Lake Veterans of Foreign Wars, Post 6356, maintaining the Veterans Building and the adjacent tennis court property in a reasonable condition so as to facilitate the use of said properties for the purposes as set forth herein. Should such use cease or substantially change, the property would then revert back to the LRA.

The real property that is transferred is more particularly described as:

A parcel of land located in the Northeast Quarter of the Northeast Quarter of Section 2, Township 26 North, Range 16 East, MDM, Lassen County, State of California more particularly described as Parcel L and Parcel M as shown on that Record of Survey for the Department of the Army, ROS # 7/26/02, recorded in Book 38 of Maps at Pages 52-61, as a single parcel of land.

Containing 2.14 acres more or less.
