#### **REGULAR MEETING MINUTES**

THURSDAY Sept, 19th, 2024

The meeting of the Lassen County Fish and Game Commission was called to order by Chairman Chris O'Brien at 7:00 pm.

Commissioner Siemer led the Pledge of Allegiance.

Agenda Approval. Chairman O'Brien requested one edit to REMINDERS: The next Lassen County Fish and Game Commission meeting will be October 17th @ 7:00 pm., at Westwood Community Center, Corner of Ash and Third Streets, Westwood CA. Commissioner Ardito moved to approve the Agenda, Smith seconded, motion carried. Minutes Approval. Commissioner Smith moved to approve the Aug 15<sup>th</sup>, 2024 Minutes as presented. Seconded by Commissioner Siemer, motion carried.

#### MATTERS INITIATED BY THE PUBLIC: none

### 1. AGENCY REPORTS:

a) CDFW – Brian Ehler is working on hunting modifications with Rob Schrag, wildlife habitat supervisor/hunting advisor. They have several Jr. hunts in the planning stages for buck tags; starting the first Saturday in September and running for nine days. A recommendation from the Fish & Game Commission is desired. Dan Ryan's recommendations have been under review for many months, proposals move slowly due to opposition to changes in the Lassen County portions. There is a move to expand boundaries to be proposed next August, 2025. Winter surveys of Deer, Pronghorn, and Elk in Northeastern California for population numbers are outdated, with the last counts being done in 2019-2020.

The Wildlife Strike Crossings Pilot Project (WCPP) on Hwy 395 is still in the planning and engineering stage. Discussion about location and the WCPP funding followed. Vice Chair Smith requested more information about the barriers, lanes, and culverts that are planned for deer migration through the Safety Corridor. Elher responded that public safety trumps environmental laws (although, there may be an exception in CEQA, California Environmental

Quality Act). Caltrans is actively working on the WCPP grant, which has funding up to \$145 million Wildlife Crossing Pilot Program (WCPP) | Caltrans.

CDFW – Paul Divine reports on the Angler's Atlas and My Catch Fishing Contest going on at Eagle Lake. Registration is free, September 1st to October 31st. Lots of great prizes from local sponsors. 2024 Eagle Lake Rainbow Rumble | Angler's Atlas (anglersatlas.com). Vice Chairman Smith asks Divine if the Eagle Lake Pine Creek Project is running. Divine responded that it is funded and design teams are meeting. Smith also asks if is it possible that trout could be classified as an endangered species? Divine responds that Champs Flat is undergoing a large meadow and stream restoration. Eagle Lake trout could be impacted by this reduction of the incision and the reconnecting of the stream to floodplain. The Fish Trap is currently getting repaired for the longevity of the building and safety. The cabin above The Fish Trap is being demolished due to the inability to bring it up to code. Chairman O'Brien thanked Elher and Divine for representing CDFW at our meetings.

- b) BLM Missy Nelson reported the horse gather is starting October 1<sup>st</sup>, 2024. Litigation resulted in 940 horses to be removed and no burros. The archeologist reported Viewland has a rubber apron. Other guzzlers are being surveyed to prioritize replacement at this time. Chairman O'Brien asks about the State Historic Preservation Officers (SHPO) agreement and whether or not it had been deemed eligible to be replaced with "in-kind" material. Minor repairs are needed on the Walsh mountain guzzler. An ACEC (Areas of critical environmental concern) crew went out to try to fix this and the work is getting slowly done. Discussion followed. BLM needs to invoice Lassen County Fish and Game Commission for their Guzzler projects.

#### 3. OLD BUSINESS:

a) Wildlife Strike Prevention and Crossings – Vice Chairman Smith contributed the 395 Corridor is #2 or the 12 top priorities for this project. It has a \$5,357,000.00 budget and they are busy identifying areas that are okay for putting in structures. The planning includes finding migration corridors from Bass Hill, to Milford and Herlong. Collaring has helped the data collection for strike prevention. Statistics say 74% of strikes are mule deer strikes.

b) Raptor Projects – Status and Next Steps – Commissioner Siemer reported that things are status quo, nothing to report.
