Subject: First Amendment to the Agreement between Lassen County and Restpadd Health Corp. to extend the Maximum Amount of the FY 2025/2026 to \$175,000 and FY 2026/2027 to \$200,000, making the Maximum Contract Amount not to exceed \$375,000.

Background:

Lassen County Health and Social Services respectfully requests approval of the First Amendment to the existing agreement between Lassen County and Restpadd Health Corp. for the provision of acute psychiatric inpatient treatment services.

Restpadd, Inc. operates a 2-unit facility that treats adults aged 18 and older and adolescents aged 13 to 17. The design of the facility prevents mingling between adults and adolescents. Each unit is staffed daily with at least two nurses and two mental health technicians.

The purpose of this amendment is to increase the maximum contract amounts for the following fiscal years to ensure the continued availability of these critical services:

- Fiscal Year 2025-2026: Increase to \$175,000
- Fiscal Year 2026-2027: Increase to \$200,000.

This results in a revised total maximum contract amount not to exceed \$375,000.

Fiscal Impact:

This Agreement will be paid from Behavioral Health Fund/Budget No.110/0751 and Mental Health Services Act Fund/Budget No. 164/0752.

Action Requested:

- 1) Approve the First Amendment to the Agreement with Restpadd Health Corp., and 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

**FIRST AMENDMENT TO AGREEMENT
BY AND BETWEEN

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and RESTPADD HEALTH CORP., with a principal place of business at 925 Walnut Street, Red Bluff CA 96080(hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2025, through June 30, 2027 (the "Agreement") in which CONTRACTOR agreed to provide acute psychiatric inpatient care to the residents of Lassen County.

2. **Amendments:** The parties agree to amend the Agreement as follows:

a. The parties desire to extend the Maximum Contract Amount for the FY 2025/26 and FY 2026/2027. Therefore, the Attachment B Payment Grid is deleted and replaced with the following:


Amendment to: Agreement with RESTPADD HEALTH CORP.
