**Subject:** Second Amendment to the Agreement Between Lassen Intervention, LLC., and Lassen County for group and individual education addressing anger management, domestic violence, and relationship issues with a Maximum Amount of \$50,850 for the term of July 01, 2024, through June 30, 2027. This amendment updates the Funding Source, Rate, Units, and Maximum Amount of the agreement for FY 2025/2026 and FY 2026/2027.

### Background:

Lassen Intervention is locally owned and has a team of therapists and mental health support staff dedicated to Lassen County residents. Lassen Intervention offers a broad range of counseling, education, and prevention services in a safe environment.

Our agreement with Lassen Intervention provides group and individual education addressing anger management, domestic violence, and relationship issues to eligible individuals through our Family Solutions-Wraparound department.

### Fiscal Impact:

This Agreement will be paid from the Community Social Services Fund and Budget 110/0754.

### Action Requested:

Approve the Second Amendment to the Agreement with Lassen Intervention, LLC.; and 2) Authorize the County Administrative Officer or Designee to execute the Amendment.

**SECOND AMENDMENT TO AGREEMENT  
BY AND BETWEEN

THIS SECOND AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and Lassen Intervention, LLC. in Susanville, California (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This Second Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2024, through June 30, 2027 (the "Agreement") in which CONTRACTOR agreed to provide group and individual education addressing anger management, domestic violence, and relationship issues to eligible individuals living in Lassen County.

2. **Amendments:** The parties agree to amend the Agreement as follows:

a. The parties desire to update the Funding Source, Rate, Units, and Maximum Amount of the agreement for FY 2025/26 and FY 2026/27. Therefore, the Payment Grid in Attachment B is deleted and replaced with the following:




