RE: Resolution to Accept JAG Grant

Subject: The Lassen County Sheriff's Office is requesting a resolution from the Lassen County Board of Supervisors to accept the funding for the Byrne JAG Grant and all subsequent funding or amendments for the next cohort of funding.

Discussion: On November 18, 2025, the Lassen County Board of Supervisors received a request from the Sheriff's Office to accept an equipment grant from Board of State and Community Corrections as a supplemental grant from the Byrne JAG Memorial Grant Program. On December 4, 2025, we were informed the resolution passed by the Board of Supervisors in 2023 would not be applicable and a new resolution would be necessary to allocate the funding.

The Sheriff's Office has since applied for the next round of funding to continue the services provided to Lassen County Schools. The requires an updated resolution which is attached.

Fiscal Impact: No fiscal impact to the general fund.

Recommendation: 1) Approve the resolution accepting the award from Byrne JAG Program authorizing the CAO to sign for funding and/or; 2) provide direction to staff.
