RE: Approval to fund 2 Child Support Specialist I/II positions

BACKGROUND

The Lassen County Department of Child Support Services is fully funded through State and Federal sources. Each year, we are required to submit our budget to the State by June. Our FY 2025–2026 budget was approved by the State on July 3, 2025, and includes funding for two additional Child Support Specialist I/II positions.

We are currently in the process of obtaining County approval for our budget. While we understand and respect the importance of this process, it is critical that we proceed with filling these positions to remain in compliance with State spending timelines.

Recruitment efforts have been ongoing since April, and we currently have one of the strongest candidate pools we've seen in years. To move forward, we are requesting Board approval to fund and fill the two additional positions as outlined in our approved State budget.

ACTION REQUESTED

Approval to fund and fill two (2) additional Child Support Specialist I/II positions within the Lassen County Department of Child Support Services. Funding to come from Lassen County Department of Child Support Services state allocation 2025/26.
