**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LASSEN, AUTHORIZING THE COUNTY ELECTIONS OFFICIAL TO CONDUCT ALL FEDERAL, STATE AND LOCAL ELECTIONS, APPROVING CONSOLIDATION OF ELECTIONS AND SHARING OF ELECTION COST**

WHEREAS, pursuant to Section §10400 of the California Elections Code, whenever two or more elections, including bond elections, of any legislative or congressional district, public district, city, county or other political subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated pursuant to this chapter upon the order of the governing body or bodies or officer or officers calling the elections.

The elections, whether held under a freeholder charter or under any state law, or both, may be consolidated, and different elections called by the same governing body may be consolidated; and

WHEREAS, pursuant to Section §10002 of the California Elections Code, the governing body of any city or district may by resolution request the board of supervisors of the county to permit the county elections official to render specified services to the city or district relating to the conduct of an election. Subject to approval of the board of supervisors, these services shall be performed by the county elections official; and the city or district shall reimburse the county in full for the services performed upon presentation of a bill to the city or district; and

WHEREAS, the Lassen County Board of Supervisors is desirous of providing for efficient and effective election administration in Lassen County;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that:

1. Pursuant to Section §10002 of the California Elections Code, approval is hereby given to all requests for services relating to the conduct of any city or district election.
2. Pursuant to Section §10400 of the California Elections Code, all requests for consolidated elections are hereby approved and ordered.
3. Pursuant to Section §10002 of the Elections Code, cities and districts shall reimburse the county for election services rendered.
4. For consolidated elections, a reasonable share of the expenses necessitated by reason of such consolidation, as determined by the Lassen County Registrar of Voters, shall be charged to and paid by each entity whose election is consolidated.

BE IT FURTHER RESOLVED the Lassen County Registrar of Voters is hereby authorized to canvass all election returns, certifying the results to the Lassen County Board of Supervisors at a regular meeting of said Board.
