SUBJECT: Notice of Completion for Mooney Road Realignment Project, Lassen County, Federal Aid Project HRRRL-5907(049).

RECOMMENDATION: Approve the Notice of Completion and authorize the Director of Public Works to sign.

DISCUSSION: Lassen County entered into a contract with Stimpel-Wiebelhaus Associates, Inc. on December 10, 2015 for the curve realignment on Mooney Road, County Road A-21 in the amount of \$1,977,203.00.

The Contractor began work on June 6, 2016 and the project was substantially completed/opened to traffic on September 27, 2016 and accepted by Larry Millar, Director of Public Works on December 14, 2017. Final acceptance by the County will be on January 23, 2018.

The final contract amount is \$2,159,594.63 which is under the total Board of Supervisors authorized amount, including contract change orders of \$2,177,203.00. The project was completed without any major issues and within the allowable working days. No liquidated damages were incurred on this project.

The attached Notice of Completion will formally close out the contract for this project.

FINANCIAL IMPACT: The total project cost of \$2,159,594.63 was paid from the FY 2015/16 through FY 2017/18 Road Construction Budgets, Fund 122-1222 with reimbursement from Federal HBRR funding.

Upon said contract, the Western Surety Company of South Dakota was the surety upon the bond by said contractor, as required by the provisions of Section 3247 to 3252, inclusive, of the Civil Code of the State of California and the State Contract Act.
