I would like \$103,663 of the Title III County Funds to be allocated to the Lassen County Sheriff's Office. These funds will be used for the following authorized uses outlined in Title III guidance:

- To reimburse the participating county for search and rescue and other emergency services, including firefighting and law enforcement patrols.
- To cover training costs and equipment purchases directly related to the emergency services described above.

Specific allocations are as follows:

<b>Training:</b>	Basic and Advanced Search and Rescue training	\$7,000
	Search and Rescue Leadership and Coordinator Meetings	\$3,000
	Snow cat training (OSHA)	\$7,000
	Communications technician training	\$6,000
	<b>Total Training</b>	<b>\$23,000</b>

<b>Equipment:</b>	Snowcat- Used State Surplus	\$10,000
	Snowcat trailer	\$15,000
	Winter rescue gear	\$10,000
	Truck- 1 ton (used)	\$45,000
	<b>Total equipment-</b>	<b>\$80,633</b>

These funds will help to equip Sheriff's Office personnel for response to fires, search and rescue operations, and other law enforcement operations conducted on lands managed by the United States Forest Service.
