**Action Requested:**  
Adopt Resolution.

**Discussion:**  
The attached resolution will set by formal action the recommended budget to include revenues and appropriations for expenditure at no greater than the fiscal year 2025-2026 adopted final budget. This action is required to comply with the County Budget Act, Government Code 29064.

**Financial Impact:**  
Adoption of the recommended budget allows departments to continue operations prior to the adoption of the final budget with the exclusion of transfers-out, new permanent employee positions, and capital assets, with exceptions for the following budgets: 100-0221, 122-1221, 122-1222, 124-1241, 141-0685, 150-1501, and 154-1541, per Government Code 29124.

**RESOLUTION ADOPTING THE RECOMMENDED BUDGET FOR THE FISCAL  
YEAR JULY 1, 2026 THROUGH JUNE 30, 2027**

**WHEREAS**, the volume of information leading up to a final budget is such that staff is still discussing the options and details, and continuing to gather information to submit to the Board for action; and

**WHEREAS**, discussions of proposed legislation often involve review of many bills and a detailed analysis of their potential effect upon the local setting before a position by the Board of Supervisors to support or oppose is justified; and

**WHEREAS**, California Government Code Sec 29000 et. seq. sets forth the legal requirements which must be taken by a Board of Supervisors for the annual adoption of a County budget; and

**WHEREAS**, on or before June 30<sup>th</sup> of each year the Board, by formal action, shall approve the recommended budget, including the revisions it deems necessary for the purpose of having authority to spend until the budget is adopted; and

**NOW, THEREFORE, BE IT RESOLVED**, that there is hereby established a recommended budget, which shall include:

1. Revenues no greater than the fiscal year 2025-2026 Adopted Budget.
2. Appropriations no greater than the fiscal year 2025-2026 Adopted Budget.
3. No payments for capital assets, with the following exceptions, transfers-out, or new permanent employee positions will be made until the adoption of the budget, unless specifically approved by the board.
4. The following budgets will include capital asset expenditures at current appropriations and applied debts: 100-0221, 122-1221, 122-1222, 124-1241, 141-0685, 150-1501, and 154-1541.
