Dear Interested Party:

The Lassen National Forest (LNF) invites your review and comment on the draft Environmental Assessment (EA) for the Dixie Postfire Restoration and Recovery Project (Project). This Project is a landscape-scale multi-phased restoration effort, encompassing 217,756 acres. It was developed in collaboration with Forest partners and input provided by the public in two separate comment periods. The Project proposes to implement a variety of treatments designed to reduce public health and safety risks and restore healthy ecosystems that are resilient to future wildfire, pests, pathogens, and other stressors.

On April 3, 2025, Secretary of Agriculture Brooke Rollins signed Secretarial Memo 1078-006, declaring an Emergency Situation under Section 40807 of the Bipartisan Infrastructure Law (IIJA). On August 12, 2025, the Lassen Forest Supervisor signed an Emergency Action Determination concluding that the Dixie Postfire Restoration and Recovery Project meets the criteria of the Emergency Situation. As a result, the project is not subject to the pre-decisional administrative review process (objection process) or other conditions listed under 36 CFR Part 218. Although this Emergency Action Determination allows for expedited implementation of critical recovery and fuels reduction work, public feedback continues to play an essential role. We encourage you to participate in this comment period to help ensure that implementation reflects local priorities and values. The Forest plans to implement some or all of these actions starting in the winter/spring of 2026.

Please submit written comments by November 17, 2025 to ensure they are considered. Electronic comments must be submitted in a format such as plain text (.txt), rich text format (.rtf), portable document format (pdf), or Microsoft Word (.doc or .docx). What is the Big Valley Groundwater Basin Advisory Committee (BVAC)?


The BVAC is the committee formed to advise the Lassen and Modoc Groundwater Sustainability Agencies (GSAs) during development and implementation of the Groundwater Sustainability Plan (GSP).

What is a Groundwater Sustainability Plan)?

A GSP is a detailed planning document, required by the Sustainable Groundwater Management Act (SGMA), that establishes a groundwater budget, minimum thresholds, and management actions to achieve long-term sustainability.

What has happened since the adoption of the revised of the GSP in April 2024?

On April 2, 2024, the GSAs obtained grant funding to implement the recommendations from the GSP and DWR approved the revised GSP in February 2025. During this meeting, we will be providing an update on the GSP implementation actions, specifically the surface storage enhancement and Adin community water system feasibility studies, and the domestic well mitigation program.

RE: Lassen County Fish and Game Commission's disappointment with the California Department of Fish and Wildlife (CDFW)

Dear Mr. Bonham:

At the October 14, 2025, Board of Supervisors meeting, Lassen County Fish and Game (LCFG) Vice Chairman, Tony Ardito, provided a report as to the current status between CDFW and LCFG. Initial remarks are attached hereto. In short, LCFG is frustrated with the chronic meeting cancellations and lack of communication provided by your agency.

The Lassen County Board of Supervisors shares this frustration and is also disappointed with the lack of engagement demonstrated to date. The situation is serious, fluid and escalating every day. Given the dire situation, the people of Lassen County demand (deserve) answers and status updates - in person. From the Board date cited above wolves have taken an additional four animals and this number is likely to change before a stamp can be placed on the envelope containing this communication. The situation demands that CDFW provide an in-person appearance at either the next LCFG meeting on November 20, 2025, or the next Board of Supervisors meeting November 18, 2025. We specifically request that you, Mr. Bonham, attend one or both of the meetings.

In addition, please respond to the bulleted questions on the attached LCFG letter. Understand, this request is separate to, and different from, the above request for in-person communication with Lassen County citizens and it is not meant to substitute the obligation of meeting with the affected citizenry of Lassen County. The last three scheduled meetings have been cancelled at the last minute by CDFW. The situation demands an immediate in-person presence. Lassen County respectfully requests that CDFW pledge to attend one or both meetings referenced above and that guarantee that a last-minute cancelation will not occur for a fourth time.
