ELECTIONS

REGISTRAR OF VOTERS

FAIR

ADJUSTMENT TO THE FAIR OPERATING HOURS

SUBJECT: Approval to change the Fair's operating hours from 9:00 a.m. to 4:00 p.m. per County Code to 10:00 a.m. to 3:00 p.m.

FISCAL IMPACT: No fiscal impact.

ACTION REQUESTED: 1) Approve the adjustment to the Fair's operating hours; and/or 2) provide direction to staff.

Executive Assistant to the County Administrative Officer/Budget Analyst/Interim Fair Manager Samantha McMullen informed the board this item was to request an adjustment to the fair hours during the winter season. The request was to deviate from the ordinance and change the operating hours to 10:00 a.m. - 3:00 p.m. for the months of November through February. The board agreed it would be beneficial. Supervisor Gallagher recommended to update the county code to reflect winter hours so the Fair Manager would not have to annually request the change. Deputy CAO Shaw suggested to amend the code after a new Fair Manager was hired.

BOARD OF SUPERVISORS

COUNTY ADMINISTRATIVE OFFICER AND FAIR MANAGER INTERVIEWS SUBJECT: Consider timing of County Administrative Officer and Fair Manager Interviews.

FISCAL IMPACT: None.

ACTION REQUESTED: Provide direction to staff.

CAO Egan informed the board Supervisor Neely requested this item to be agendized for discussion to consider postponing the County Administrative Officer and Fair Manager interviews until the new Supervisor District 1 Elect assumes office. Sheriff/Coroner John McGarva discussed his concerns with postponing the interviews and suggested to conduct interviews sooner than later. Supervisor Albaugh stated his personal preference would be to continue with the interviews as he felt it would be unfair to the candidates to postpone the process further. Supervisors Bridges and Gallagher agreed with Supervisor Albaugh. Supervisor Ingram stated he didn't have a preference and asked if the Fair Manager position was advertised on www.indeed.com. CAO Egan replied, "No." Supervisor Ingram said, "While we're here, John got a bunch of applications with Indeed (www.indeed.com), why aren't we not flying this Fair Manager job on a real search engine? We're searching for a Fair Manager Right? Why are we not flying? We directed staff to fly these jobs, especially the Fair Manager. Me and Tom Neely both did and it's not being flown? Why? What did we direct staff to do? So we're just in the stupid

Modoc Newspaper again? How the hell are we going to get a qualified applicant?" Supervisor Albaugh stated, "Two people do not make a quorum to provide direction to staff. So that's a misnomer. It has to be three of us." Supervisor Ingram stated, "Well I'm glad three people are morons." Supervisor Albaugh said, "That was brilliant. That was an absolutely brilliant statement. Thank you. So...oh wow!" Supervisor Albaugh reminded the board there were two positions but couldn't conduct interviews for the Fair Manager due to the lack of applicants, however they could continue with the CAO interviews. Supervisor Gallagher suggested to stay on the timeline with the special meeting scheduled for December 4, 2024, to conduct interviews. Discussion was held pertaining to the re-advertisement of the Fair Manager position and additional search engines other than Indeed.com. The consensus of the board was to conduct CAO interviews at the December 4, 2024, special Board of Supervisors meeting and directed Personnel to re-advertise the Fair Manager position.

HOUSING AND GRANTS AGREEMENT BETWEEN LASSEN COUNTY AND HOUSING TOOLS, LLC

SUBJECT: Agreement between Lassen County and Housing Tools, LLC. to provide services related to facilitating the development of housing and expansion of housing-related services in the amount of \$75,000.00 for Fiscal Year 2024/2025 and Fiscal Year 2025/2026.

FISCAL IMPACT: This Agreement will be paid from Grants and Loans Fund/Budget Unit No. 110-0941 and is included in the Fiscal Year 2024/2025 budget.

ACTION REQUESTED: 1) Approve the Agreement with Housing Tools, LLC.; and 2) authorize the County Administrative Officer or Designee to execute the agreement.

Health and Social Services Housing Program Manager Grace Poor stated the item was a proposed agreement with Housing Tools, LLC and Lassen County. This item was presented at the prior board meeting and was reagendized for today. This agreement would provide assistance for reporting, program compliance, policies and procedures, and grant preparation. CAO Egan asked how the agreement was revised from the prior agreement previously presented. Program Manager Poor stated the revised contract was more detailed and the state had made changes to the housing allocation. Housing Tools, LLC worked for the benefit of the county with the hope to change decisions made by the state. Brief discussion was held pertaining to grant funding.
