Subject: Purchase of Public Safety Equipment

**Recommendation:** Board of Supervisors approve the purchase and authorize the Probation Department to purchase the requested Body Worn Cameras from Axon in an amount not to exceed \$551,384.03.

**Discussion:** On September 23, 2025, The Board of Supervisors approved the allocation of \$950,000.00 from the Community Correction Partnership (CCP) Budget towards public safety equipment. The CCP met and determined the immediate equipment need were Body Worn Cameras. These are a sole source item provided through Axon Enterprise, no competing bids or quotes were obtainable and Axon Enterprise has requirements for specific training and operations. This purchase will serve both the Probation Department and Sheriff's Department. This will allow our agencies to continue our field operations with up to date equipment for Post Release Community Supervision and high-Risk Felons. The Board could put out a Request for Proposals and Axon would be the only likely respondent.

**Financial Impact:** The purchase will come from budget unit 138-0551 Public Safety Equipment.

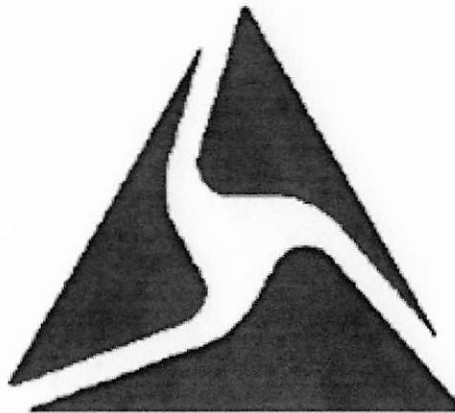
