SUBJECT : Continuation of Lassen County District Attorney's

Victim/Witness Assistance Program

Recommendation: That the Lassen County Board of Supervisors authorize the Board Chairman to execute the original Resolution of the Board of Supervisors Of Lassen County Approving The Undertaking Of The Lassen County District Attorney's Victim/Witness Assistance program To Be Funded From Funds Available Through the State of California Administered by the California Office of Emergency Services **and** authorize the Lassen County District Attorney and the Lassen County Administrative Officer to execute any and all documents necessary in order to continue the grant funding for the Victim/Witness Assistance Program for grant year 2022/2023.

Summary: The Lassen County District Attorney's Victim/Witness Assistance Program has been in existence since 1991. Grant year 2022/2023 will mark our 30th year of operation. The program is funded through the State of California utilizing both State and Federal monies. The goal of the program is to provide comprehensive services to victims of crime in Lassen County to lessen trauma experienced while the case moves its way through the criminal justice system. For 2022/2023, the program will be staffed with 2.05 full time equivalent (FTE) positions; one Victim/Witness Coordinator I/II will devote 100% of their time to the Victim/Witness Assistance Program and handle the day-to-day programmatic responsibilities, as well as carry a case load; one Victim/Witness Advocate/ Mass Victimization Advocate I/II will devote 100% of their time to the Victim/Witness Assistance creating protocols for a crisis response for a mass criminalization incident and carry a full case load, lastly, one District Attorney Program Coordinator will devote 5% (2 hours a week) (a decrease from 7.5%/3 hours a week) of their time to handle all of the Victim/Witness Assistance Program fiscal responsibilities.

It is the District Attorney's philosophy to attempt to isolate grant funding as much to personnel costs as possible and devote the least amount of the funding to operational costs. Therefore, we are requesting the minimum amounts in operating expenses necessary to support the program, including funds required for mandatory and continuing training. Our grant budget includes the maximum amount allowable under the grant for the amounts charged to the program for Workers Compensation Insurance and Liability Insurance. We have set aside an amount for the costs of office supplies, postage expenses, indirect costs (A-87), rent, memberships to victim services associations, trainings and vehicle maintenance. Due to the grant being due prior to the county having

figures for Worker Compensation Insurance, Liability Insurance, PERS Unfunded Retirement, A-87 and rent, our numbers are estimates, however, if these funds exceed our estimates the grant may not be able to cover the overages. We cannot ask the grant for additional funds.

Financial Impact: The costs of the District Attorney's Victim/Witness Assistance Program is reimbursed to Lassen County through the grant administered by the California Office of Emergency Services, Victim Services & Public Safety Branch, Public Safety Division, and Victim Witness Unit. The Victim/Witness allocation to Lassen County for fiscal/grant year 2022/2023 will be \$235,116.00; an increase of \$14,330.00 compared to the amount of the grant award from the 2021/2022 fiscal year.

Other Agency Involvement: There are no other County agencies involved with this project.
