SUBJECT: Consider Certification of a Subsequent Environmental Impact Report (EIR) for a proposal to amend mining operations at the Ward Lake Pit (CA mine ID #91-18-0008). If approved, the amendment would allow for the expansion of approximately 78.6 acres, with an associated additional volume of 5,000,000 tons of material; extension of the life of the mine from 2030 to 2050; and an increase of the maximum volume per year from 100,000 tons to 200,000 tons per year. (File EIR #2021-001, UP #2021-003 and RP #2021-001). FISCAL IMPACT: None.
