RE: Fall River Resource Conservation District Vacancies

This letter is to inform you that Bill Buckman has moved and is not longer residing in Lassen County as of September 30, 2022 and he wishes to fill the Shasta County vacancy left by Dan Klatt. This leaves an opening in the Lassen County area.

A notice of vacancy was posted in July 2022 and has been placed at the following locations for more than the required 21 days: Fall River Mills Post Office, McArhur Post Office, and the Fall River RCD Office. There has only been one candidate application received during the notice of vacancy posting period. The applicant, Chris Camarata, a resident of Shasta County asked to be appointed to the open position.

At the November 22, 2022 special board meeting, the Board of Directors of the Fall River RCD held an election to fill 1 vacancy in Shasta County and 1 vacancy in Lassen County. The new applicant, Chris Camarata is qualified to hold the position and does reside in Lassen County. The chair asked for a motion to appoint the candidtes as listed above. Motion to appoint was made by Don Martin second by , motion approved 5 to 0, one board member was absent.

Bill Buckman has been appointed to move from the Lassen County position and to fill the Shasta County vacancy and Chris Camarata is the newly appointed board member for the Lassen vacancy, attached is Mr Camarata's application for appointment.

Based on the above actions, the Board respectfully requests that the Shasta County Board of Supervisors re-appoint Bill Buckman to the Shasta County position and Chris Camarata to his first term as a director for the Fall River RCD in the Lassen County position.
