DISCUSSION: Section 2121 of the Streets and Highways Code for the State of California provides that, during the month of May of each year; each County shall submit to the Department of Transportation any additions or deletions from its mileage of maintained County Roads.

The mileage of the maintained County Roads has not changed from the 2015 maintained mileage reported as 881.044 miles as is indicated in Resolutions and kept in the County Road Department files.

Therefore the total maintained mileage for 2016 is 881.044 miles.
