SUBJECT: Resolution of Intention to Vacate Olson Road, County Road 532.

RECOMMENDATION: 1) Consider abandoning/vacating Olson Road, County Road 532 2) Adopt Resolution No. 17- ____ "Resolution of Intention to Vacate Olson Road, County Road 532."

<u>DISCUSSION</u>: Lassen County has been approached by Dennis and Merrill Daugherty as to the abandoning/vacating of the entire section of Olson Road, County Road 532 which runs through property owned by the Daugherty's and ends at the property of Merrill and Jane Daugherty, 714-200 Olson Road.

The proposed abandonment/vacation would be the entire 1.400 miles beginning at its intersection with Madeline Road, County Road 547 in Section 15, Township 37 North, Range 13 East, MDM&M to its end at 714-200 Olson Road. Surrounding properties are owned by Daugherty and USA. The USA properties have access from Clarks Valley Road, County Road 510 and other access points. See attached resolution and map.

The Road Department is in favor of abandoning/vacating Olson Road as it is entirely within the Daugherty private property and does not appear to be necessary for present or future public use. This road has been utilized as a private driveway with little to no public use for years.

The Planning Commission is scheduled to review this abandonment/vacation request of Olson Road for General Plan Determination pursuant to Section 65402 of the Government Code at their July meeting.

The Attached Resolution follows the guidelines of Section 8320 of the Street and Highways Code which sets a public hearing date and authorizes the noticing of this public hearing in the local newspaper and posting notices at the site.

<u>ALTERNATIVES</u>: Do not adopt Resolution.

<u>FINANCIAL IMPACT</u>: Potential insignificant reduction in Highway Users Gas Tax revenue to Fund 122-1221 which is more than recovered with the removal of this section from the County's liability and maintenance responsibilities.

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LASSEN ISSUING A NOTICE OF INTENTION TO ABANDON/VACATE OLSON ROAD, COUNTY ROAD 532.

WHEREAS, Division 9, Section 8312 of California Streets and Highways Code authorizes the Board of Supervisors to consider the abandonment/vacation of a road or portion of road which is in the County Maintained Road System; and

WHEREAS, Division 9, Section 8320 of the California Streets and Highways Code provides that the Board of Supervisors may initiate a proceeding, by resolution, for the Intention to Vacate a road of portion of road which is in the County Maintained Road System if it finds that the road or portion of road is unnecessary for the public convenience.

WHEREAS, the Lassen County Public Works Department requests that the entire 1.400 miles of Olson Road, County Road 532, from its intersection with Madeline Road, County Road 510 in Section 15, Township 37 North, Range 13 East, MDM&M, to its end be considered for abandonment/vacation as shown on Exhibit "A" attached hereto; and

WHEREAS, Sections 8322 and 8323 of the California Streets and Highways Code specifies the publication and noticing requirements for a proposed roadway abandonment/vacation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Lassen as follows:

- 1. This Board of Supervisors hereby sets a Public Hearing for 10:30 am on July 18, 2017 at the Board of Supervisors chambers located at 707 Nevada Street, Susanville, California for the purpose of considering the abandonment/vacation of the entire 1.400 miles of Olson Road, County Road 532.
- 2. This Board of Supervisors hereby finds and declares a Notice of Intention, as described herein, shall be published as required by Division 9, Section 8322 of the California Streets and Highways Code once a week, for two successive weeks, in a newspaper of general circulation in the County of Lassen, on or before July 18, 2017.
- 3. This Board of Supervisors hereby finds and declares a Notice of Intention, as described herein, shall be posted as required by Division 9, Section 8323 of the California Streets and Highways Code at least two weeks before the hearing date along Olson Road being considered for vacating, on or before July 18, 2017.
- 4. The Public Works Director is authorized and directed to act on behalf of the County on all matters pertaining to this action.
