REF: New vehicle purchase

Greetings and salutations:

The District Attorney's Office has two vehicles in very poor condition both well in excess of 100,000 miles. The Durango is 15 years old and the Expedition is 13 years old. Both vehicles are mechanically unsound, just recently, I was stranded in a construction zone because of overheating. Neither of our vehicles have had any major repairs and it is only a matter of time before a transmission or engine failure takes place. Neither vehicle would be worth the amount it would cost to repair. The current vehicles get around 10 City / 14 Highway.

As the Senior Investigator and sworn peace officer, I travel Lassen County in its entirety. I not unlike a Deputy, have to run lights and siren to emergency calls anywhere in the county. I also do follow-up investigations throughout Lassen County.

For the stated reasons, I am asking the board approve the District Attorney's Office to make an immediate vehicle purchase not to exceed \$30,000.

I have researched the current state bids and I contacted CAL E procurement. The Ford Taurus is no longer on state bid because it is not green E85 capable. The only vehicle's that can be purchased for the requested \$30,000 is the Ford Interceptor base model and the Dodge Charger base model.

The Ford Interceptor would need additional cost for equipment as it would require equipment that fits into a center console at a cost of \$3,277.00. We can use our old equipment with the Charger.

I request permission to purchase the AWD V6 Police Charger for 30,000 which includes sales tax and tire tax. Production would start in July and delivery would be around September.
