<u>DISCUSSION:</u> Lassen County entered into a contract with Hat Creek Construction and Materials, Inc. on June 24, 2016 for the bid amount of \$351,025.00.

The project was completed and accepted by Larry Millar, Director of Public Works on July 17, 2017. Final acceptance by the County will be on September 26, 2017.

The final contract amount is \$355,856.62 which is under the total Board of Supervisors authorized amount, including contract change orders, of \$421,230.00. The project was completed without any major issues and within the allowable working days. No liquidated damages were incurred on this project.

The attached Notice of Completion will formally close out the contract for this project.
