### **SUMMARY**

The purpose of this Board letter is to provide information regarding an ordinance, which is proposed by staff to repeal Chapter 18.140 (Water Utility Rates for the Johnstonville Water System) of Lassen County Code. The proposed ordinance and a copy of Lassen County Code Chapter 18.140, as it currently exists, are attached.

In summary, the ordinance is being proposed because the County no longer owns operates or maintains the Johnstonville Water System, and because CSA # 2 has been dissolved, the Utility Rates found in section 18.140 of Lassen County Code no longer serve purpose.

The utility rates for the Johnstonville Water System were adopted in 1994, to facilitate water connection, and service at County Service Area No. 2 (CSA 2). On August 19, 2014, the Lassen County Board of Supervisors adopted resolution 14-045, transferring ownership, operation, and maintenance of the Johnstonville Water System to the City of Susanville. On April 14, 2015, the Lassen County Board of Supervisors adopted Resolution No. 15-029, directing staff to proceed with the dissolution of CSA 2. On August 10, 2015 the Local Agency Formation Commission adopted resolution 2015-0005 ordering the change of organization, and on October 6, 2015, a certificate of completion was recorded for the Dissolution of CSA #2 Johnstonville Water System.

Again, it is the determination of the Planning and Building Services Department that the requirements found in Chapter 18.140, are no longer needed, as the County no longer owns, operates, or maintains the Johnstonville Water System. That said, the Department recommends that the Board introduce the ordinance to repeal Chapter 18.140 and adopt said ordinance at a future meeting.

## THE BOARD OF SUPERVISORS OF THE COUNTY OF LASSEN ORDAINS AS FOLLOWS:

**SECTION ONE:** This ordinance shall take effect thirty (30) days from the date of its passage, and before the expiration of fifteen (15) days after its passage a summary shall be published with the names of the members voting for and against the same, once in a local newspaper of the County of Lassen, State of California.

SECTION TWO: PURPOSE. The proposed ordinance repeals, in its entirety, Chapter 18.140 (Water Utility Rates for the Johnstonville Water System) of the Lassen County Code, because the requirements found therein are no longer needed. The utility rates for the Johnstonville Water System were adopted in 1994, to facilitate water connection, and service at County Service Area No. 2 (CSA 2). On August 19, 2014, the Lassen County Board of Supervisors adopted resolution 14-045, transferring ownership, operation, and maintenance of the Johnstonville Water System to the City of Susanville. On April 14, 2015, the Lassen County Board of Supervisors adopted Resolution No. 15-029, directing staff to proceed with the dissolution of CSA 2. **SECTION THREE:** Chapter 18.140 of the Lassen County Code is hereby repealed.

**SECTION FOUR:** If any section, subsection, sentence, clause, or phase of this ordinance is for any reason held to be unconstitutional and invalid, such decision shall not affect the validity of the remaining portion of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and every section, subsection, sentence, clause or phrase thereof, irrespective of the fact any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional or invalid.

### Chapter 18.140 WATER UTILITY RATES FOR THE JOHNSTONVILLE WATER SYSTEM

### 18.140.010 Charges for water service.

The charges for services and water used by customers of the Johnstonville water system shall be fixed from time to time by resolution of the Lassen County board of supervisors. (Ord. 521-A § 2, 2010; Ord. 521 § 1, 1994).

#### 18.140.020 Connection fees.

The fee for connection to the Johnstonville water system shall be the actual cost, in labor and materials, to extend the water system's main to the customer's property and to connect the customer's service line to the water system main and shall include the cost of the water meter. (Ord. 521-A § 3, 2010; Ord. 521 § 2, 1994).
