SUBJECT: Award bid for one (1) new 5-7 Cubic Yard Dump Truck to Sierra Freightliner, Sparks, NV.

RECOMMENDATION: Award bid for one 2019 Freightliner 108SD complete with front and wing snow plows and tailgate sander/spreader to Sierra Freightliner, Sparks, Nevada, the lowest bidder meeting the specifications in the amount of \$176,020.85.

DISCUSSION: Formal bidding procedures were completed with a bid opening on November 2, 2017. A total of six (6) bid packages were sent out with the following four (4) bids being received:

Silver State International, Sparks, NV	\$175,933.46 (2018 International 7400 SFA)
Sierra Freightliner, Sparks, NV	\$176,020.85 (2019 Freightliner 108SD)
Redding Freightliner, Redding, CA	\$180,394.00 (2019 Freightliner 108SD, 13,300 lb front axle)
Redding Freightliner, Redding, CA	\$181,126.00 (2019 Freightliner 108SD, 14,700 lb. front axle)

It is recommended that the bid be awarded to Sierra Freightliner for a 2019 Freightliner 108SD in the amount of \$176,020.85 as their bid is the lowest bid meeting the bid specifications. The bid from Silver State International for a 2018 International 7400 SFA does not meet all of the bid specifications. See attached bids.

This truck will be replacing a dump truck which was damaged in an accident, a 1984 Ford F-7000 5 cubic yard dump truck (TD-12).


This new truck is being equipped with a front plow, a wing plow and a rear sander/spreader. This allows us to be more efficient with our snow plowing activities, allowing us to eliminate additional trips to widen out the roadway. This truck will be utilized throughout the County.

ALTERNATIVE: Not Approve.

FINANCIAL IMPACT: Funding in the amount of \$176,020.85 will be paid out of the current FY 2017/18 Road Operating Budget, Fund 122-1221 with reimbursement in the approximate amount of \$140,000 coming from the insurance claim.
