IN HONOR OF

PETER M. HOLMAN

ON HIS RETIREMENT FROM THE LASSEN COUNTY SHERIFF'S OFFICE

Whereas, PETE HOLMAN began his employment on October 20, 1997 as Deputy Sheriff until June 23, 2013, when the position was reclassified to Deputy Sheriff./Coroner II, a position he held until his retirement on November 10, 2017; and,

Whereas, **PETE HOLMAN** came to Lassen County from the Tule Lake Police Department. His first assignment was a Resident Deputy in Big Valley providing general law enforcement services to the residents north of Eagle Lake and from the Shasta County line to the Nevada border. In 2007, he transferred to patrol out of the Susanville Sheriff's Office. He also served as Bailiff in Lassen County Superior Court. In March 2017, he was assigned the Big Valley patrol area to finish his career working where he started; and,

PETE HOLMAN has always served with a smile and is a joy to be around. He is one of those people you always look forward to seeing and hearing about his adventures. His love for the outdoors and baseball have led him to many out-of-state hunts and trips to Reno to watch the Aces play. Pete formed the Lassen County Mule Deer Foundation and devoted his time planning, raising funds and completing habitat projects.
