## Background:

On July 25, 2017, the Board of Supervisors approved the list of Health and Social Services contracts for Fiscal Year 17/18. Unfortunately, the amount on the spreadsheet was incorrect at that time and we are presenting this to the Board to correct that error. The correct amount is shown on the Amendment to be \$5,250.00.

### **Fiscal Impact:**

There is no impact to County General Funds. Costs are covered by Behavioral Health Mental Health Services Act (MHSA) funds.

### **Action Requested:**

# FIRST AMENDMENT TO AGREEMENT BY AND BETWEEN LASSEN COUNTY AND THEODORE TAMBORSKI

THIS FIRST AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and THEODRORE TAMBORSKI (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This First Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2016 through June 30, 2017, (the "Agreement") in which CONTRACTOR agreed to snow removal services at the Westwood One-Stop.

- 2. Amendments: The parties agree to amend the Agreement as follows:
  - a. The parties desire to extend the term of the agreement for one additional year, FY 2017/18. Therefore, the first sentence of Paragraph 2 is deleted and replaced with the following:
    - "The term of this agreement shall be for the period of July 1, 2016 through June 30, 2018."
  - b. The parties desire to extend the Maximum Contract Amount to include FY 2017/18. Therefore, Paragraph B.2 is deleted and replaced with the following:
