<u>DISCUSSION:</u> Lassen County entered into a contract with United Building Contractors, Inc. on November 28, 2016 for the remodel of an office building, located at 2950 Riverside Dr., Susanville, in the amount of \$979,000.00

The Contractor began work on November 29, 2016 and the project was completed and accepted by Larry Millar, Director of Public Works on March 31, 2017. Final acceptance by the County will be on February 13, 2018.

The final contract amount is \$974,567.21, which is under the total authorized amount, including contract change orders deduction of \$4,432.79. The project was completed without any major issues and within the allowable working days. No liquidated damages were incurred on this project.

The attached Notice of Completion will formally close out the contract for this project.
