## **Discussion:**

The Sheriff's Office purchased new body armor for the Special Weapons and Tactics Team in November of 2016. The body armor provides Level IIIA protection with front and back ballistic plates. This purchase will be for accessory pieces that cover other vital areas of the body.

This purchase would exceed the \$25,000 total spending threshold per vendor/per year and requires Board of Supervisor approval.

We are requesting the Board authorize the purchase of this equipment from Pro Force, vendor of the original purchase.

## **Fiscal Impact:**

Purchase cost would be expended from the safety line in the Sheriff's Patrol Budget 130-0522.

**Recommendation:** 

That the Board of Supervisors authorize the purchase of the body armor from Pro

Force Law Enforcement, in the amount of \$5,024.77.
