

Goodfred Bridge Replacement and Roadway Rehabilitation Project

The California Department of Transportation (Caltrans) has prepared a Draft Initial Study with a proposed Mitigated Negative Declaration (ISMND), for a proposed bridge replacement and roadway rehabilitation project on State Route 36 from post miles (PM) 6.0 to PM 14.6 in Lassen County. The purpose of the project is to provide a bridge and roadway that meet modern highway design standards, accommodates interregional transportation needs, reduces maintenance costs, and provides safety for the traveling public.

The Draft ISMND is being circulated for public and agency review in accordance with CEQA Guidelines §15073. Enclosed is a CD including an electronic copy of the Goodfred Bridge Replacement and Roadway Rehabilitation Project Draft ISMND. 

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION PURSUANT TO CEQA

What is Planned

Caltrans, with the Federal Highway Administration (FHWA) is proposing to replace the Goodrich Creek Bridge and rehabilitate an 8.6-mile stretch of roadway on State Route 36 in Lassen County. This project starts just east of the town of Westwood from and runs from Post Mile (PM) 6.0 to PM 14.6. Shoulder widening, tree removal to provide a clear recovery zone, the repair and/or replacement of culverts, as well as a minor three segment curve correction are also part of the project.

Notice of Availability

Caltrans and the FHWA have prepared a Draft Initial Study/Mitigated Negative Declaration (IS/MND) for the Goodfred Bridge Replacement and Roadway Rehabilitation Project. This notice is to inform you of the preparation of the IS/MND and of its availability for you to review.

The IS/MND is available for public review from February 15, 2018 to March 15, 2018. LOT LINE ADJUSTMENT # 2018-002, Ray Artinian, Mark Philipsen. The applicants are proposing a lot line adjustment between two parcels. Currently, Parcel A is approximately 35,000 square feet in size, and Parcel B is approximately 20,000 square feet in size. If the lot line adjustment were approved, Resultant Parcel A would be approximately 29,000 square feet in size and Resultant Parcel B would be approximately 26,000 square feet in size. Both parcels are zoned R-1-D (Single Family Residential District, Design Combining District).
