SUBJECT: Resolution Certifying County Maintained Road Mileage for 2017

RECOMMENDATION: That the Board of Supervisors adopts Resolution 18-
"Resolution Certifying 2017 County Maintained Road Mileage."

DISCUSSION: Section 2121 of the Streets and Highways Code for the State of California provides that, during the month of May of each year; each County shall submit to the Department of Transportation any additions or deletions from its mileage of maintained County Roads.

The mileage of the maintained County Roads has changed from the 2016 maintained mileage reported as 881.044 miles as is indicated in Resolutions and kept in the County Road Department files. The previously reported mileage of 881.044 miles has remained consistent since the 2008 Certified Maintained Mileage.

The following roads and/or portions of roads have been removed from the County Maintained Road System:

The removal (deletion) of these two roads and/or portions of roads from the Maintained Road System results in a decrease of 1.910 miles which results in the total maintained mileage for 2017 of 879.134 miles.


Therefore the total maintained mileage for 2017 is 879.134 miles.

ALTERNATIVES: Additions and deletions can be made; however, changes must be submitted to Caltrans.

FINANCIAL IMPACT: Minimal decrease (approximately 0.2 %) in highway user tax revenue however overall savings to Road Fund with deletion of road maintenance requirements.

RESOLUTION CERTIFYING 2017 COUNTY MAINTAINED ROAD MILEAGE

WHEREAS, the following roads and/or portions of roads have been removed from the County Maintained Road System:

WHEREAS, the California Department of Transportation Certified to the State Controller that the total mileage of maintained County Roads in Lassen County for 2016 was 881.044 miles.

WHEREAS, the revised total County Maintained Road mileage for 2017 is 879.134 miles.

NOW, THEREFORE, BE IT RESOLVED, that the Lassen County Board of Supervisors certifies the total mileage of maintained roads, in Lassen County for 2017, to be **879.134 miles**.
