Discussion:

The Sheriff's Office received a grant in the amount of \$42,907 from the California Department of Park and Recreation, Off-Highway Vehicle Law Enforcement program. The purpose of this grant is to purchase a used Sport Utility Vehicle capable of being used in the OHV areas, as well as on roadways.
