IN HONOR OF

ON HER RETIREMENT FROM THE
LASSEN COUNTY PERSONNEL DEPARTMENT

Whereas, **CHERYL DOUGLAS** began her employment as extra help on December 10, 1990 as a Secretary in the Personnel Department; after working in several County departments and capacities, she returned to the Personnel Department as an Administrative Clerk on February 24, 2001; the position was reclassified to Program Assistant Benefits on September 1, 2001; promoted to Safety Program Coordinator I on January 19, 2009; promoted to Safety Program Coordinator II on January 19, 2010; the position was reclassified to Personnel/Risk Analyst on August 12, 2014, a position she held until her retirement on August 31, 2018; and,

Whereas, **CHERYL DOUGLAS** has performed all job functions of the Personnel Department. She provided staff supervision, assisted with collective bargaining, implementation of employee MOUs, performed recruitment, application screening, job classifications, employee orientation, benefits oversight, and job descriptions. She facilitated employee discipline recommendations/actions, payroll actions and reviewed performance evaluations. She administered County insurance policies, worker's compensation and risk management programs. She performed safety inspections and led County-wide safety meetings and safety training with Department Safety Representatives. She facilitated mandated training for supervisors and managers, including online training, and conducted Trindel Insurance Audit compliant inspections and records management. She administered the County's Personnel Rules, IIPP policies and so much more; and,

Whereas, **CHERYL DOUGLAS** will be missed for her institutional knowledge of personnel and safety matters. Her enthusiasm for the job and dedication to the health, safety and well-being of the work force is greatly appreciated. She was always professional and committed to the Department and the employees of Lassen County.
