<u>RECOMMENDATION</u>: That the Board of Supervisor's 1) Award the bid to Schnetzer Engineering, Inc., in the amount of \$144,830.40, and authorize the Public Works Director to sign the Agreement. 2) Authorize Public Works Director to enter into change orders up to the amount of \$10,000 for a total not –to-exceed amount of \$154,830.40.

<u>DISCUSSION</u>: Formal bidding procedures were completed with a bid opening on Thursday, September 6, 2018. A total of ten (10) bid packages were sent out with the following one (1) bid being received:

Schnetzer Engineering, Inc., Redding, CA

\$144,830.40

This bid is a responsive bids meeting the bid specifications, and therefore, it is recommended that the award be made to Schnetzer Engineering, Inc., the low bidder in the amount of \$144,830.40. Schnetzer Engineering has completed rock crushing for the County in the past where they did an excellent job.

This contract consists of the production/crushing and stockpiling of 12,000 CY of 1 ½" Class 3 Aggregate Base material in the Nor Cal Land & Cattle Company owned Pit located outside Adin, California whereby the County currently has an Agreement to remove aggregate materials This material will be utilized on various County roads, mainly in the Bieber, Little Vallley and Pittville areas.

<u>FINANCIAL IMPACT</u>: Maximum contract amount of \$154,830.40 from Road Budget, Fund 122-1221 where funding in the amount of \$155,000 is budgeted this fiscal year.
