RESOLUTION OF THE LASSEN COUNTY BOARD OF SUPERVISORS CONCURRING IN  
THE CONTINUATION OF THE DECLARATION OF A LOCAL EMERGENCY

WHEREAS, a local emergency continues to exist in the County of Lassen in accordance with the proclamation by the Board of Supervisors made on July 31, 2018, by Resolution No. 18-049, incorporated herein by this reference, as a result of conditions of extreme peril to the safety of persons and property have arisen within the county caused by the Whaleback Fire, commencing on or about July 27, 2018, at which time the Board of Supervisors was not in session; and,

WHEREAS, the Board of Supervisors does hereby find that the previously mentioned conditions of extreme peril did warrant and necessitate the proclamation of a local emergency and a request to the Governor of the State of California to Proclaim a State of Emergency throughout Lassen County; and

WHEREAS, on August 28, 2018, by Resolution No. 18-058, the Board of Supervisors concurred in the continuation of said local emergency; and

WHEREAS, the aforesaid conditions are, or are and continue to be, beyond the control of the services, personnel, equipment, and facilities of Lassen County; and

NOW, THEREFORE, BE IT RESOLVED that the Lassen County Board of Supervisors concurs in the continuation of said local emergency and orders this said local emergency shall be deemed to continue to exist until its termination is proclaimed by the Board of Supervisors of the County of Lassen, State of California.

BE IT FURTHER RESOLVED the powers, functions, and duties of the emergency organization of the County of Lassen shall be those prescribed by state law, local ordinance, and resolutions of the County of Lassen and the Board of Supervisors shall review the need for continuing the local emergency at least once every 30 days until its termination is proclaimed by the Board of Supervisors.

BE IT FURTHER RESOLVED that a copy of this proclamation shall be forwarded to the Governor of California with a request that he proclaim the County of Lassen to be in a state of emergency and that he make available California Disaster Assistance Act disaster assistance and relief programs to Lassen County; and further that the Governor request a Presidential Declaration.

The foregoing resolution was adopted at a regular meeting of the Board of Supervisors of the County of Lassen, State of California, held on the 25th day of September, 2018, by the following vote:
