<u>DISCUSSION:</u> The Road Department has recently replaced a 1992 Ford Ranger (P-33), which is in a usable fair condition.

The Lassen County Waterworks District 1 (Bieber) has requested that the County consider the surplus/sale of this vehicle to the Lassen County Waterworks District 1 for a price of \$500.00. See attached letter.
