Discussion:

In December 2018, the Lassen County Sheriff's Office purchased a 2019 Honda Pioneer Side by Side Off Highway Vehicle with snow tracks through Gridley Honda in Gridley, California, utilizing the Title III funds for the purpose of supporting search and rescue operations. The complete cost of this vehicle with accessories came to \$24,832.71. Although this vehicle came with a solid hard top and windshield, it is not fully enclosed, and does not have hard doors or side mirrors.

As stated above, this vehicle is primarily utilized in support of search and rescue operations. During a search and rescue mission, there may be a need to transport civilians in this vehicle. During the winter months, travel in this vehicle without a complete enclosure exposes the driver and passengers to the adverse elements. The Sheriff's Office has received quotes from three vendors for the enclosure. Gridley Honda submitted the lowest quote. We asked that they also include the cost of a kit that includes a defroster for the windshield. The total purchase amount is \$4,260.60. This purchase requires approval of the Board of Supervisors because when combined with the initial purchase, it exceeds \$25,000.

Fiscal Impact:

The funds for the purchase will come from Title III funds in 142-0023.

Recommendation:

That the Lassen County Board of Supervisors approve the purchase from Gridley Honda in the amount of \$4,260.60.
